1. I am counsel of record for Plaintiffs in this matter. I am familiar with the facts and proceedings in this matter and have personal knowledge of the matters stated in this Declaration.

2. I am a partner in the law firm of Holland & Hart LLP (“Holland & Hart”) and am duly licensed to practice law in the State of Idaho. I am attorney of record for Plaintiffs, and I make this declaration based upon my own personal knowledge of the matters stated herein.

Attached hereto as **Exhibit D** are true and correct copies of emails I sent to Diego Rodriguez on June 2, 2022, June 22, 2022, and July 8, 2022, without attachments. Mr. Rodriguez did not respond to these emails; nor did any attorney respond on his behalf.

7. Attached hereto as **Exhibit E** is a true and correct copy of an Idaho Statesman article dated June 30, 2022, wherein Diego Rodriguez responded to a reporter’s request for comment regarding the litigation.

10. Despite being served with the Amended Order and having several weeks to comply with the Court's directive, Mr. Rodriguez did not respond to Plaintiffs' interrogatories in any way by the Court-ordered date of August 5, 2022.

11. On August 19, 2022, Plaintiffs filed their motion for sanctions as to Mr. Rodriguez, with a notice of hearing for September 6, 2022. I caused Plaintiffs' notice of hearing and motion for sanctions as to Diego Rodriguez, with all of the supporting documents, to be mailed to Diego Rodriguez at his Orlando, Florida address. Mr. Rodriguez still did not respond to the interrogatories.

12. Mr. Rodriguez did not attend the September 6, 2022 hearing on the motion for sanctions against him. He did, however, file an Answer on September 6, 2022.

13. Attached hereto as **Exhibit G** is an email I received from Diego Rodriguez dated September 10, 2022, purporting to respond to the five Interrogatories addressed in the Amended Order.

14. On September 21, 2022, pursuant to the Court's Sanctions Order, I caused to be noticed the deposition of Mr. Rodriguez for a date he confirmed he was available—October 5, 2022.

15. A week later, Mr. Rodriguez emailed me incomplete responses to the five Interrogatories addressed in the Amended Order. Attached hereto as **Exhibit H** are Defendant's Responses to Plaintiffs First Set of Interrogatories to Defendant Diego Rodriguez, signed September 28, 2022.

16. On October 3, 2022, Mr. Rodriguez emailed me with objections to the deposition, including a contention about the Sanctions Order being confusing because of a typo. This objection seemed particularly disingenuous and was asserted so close to the deposition date and included with insults and false statements that it appeared intended solely to obstruct the legal process. Nevertheless, I explained why the Sanctions Order was not ambiguous. Attached hereto as **Exhibit I** is a true and correct copy of the email string including this correspondence.

17. Mr. Rodriguez clearly understood from the Sanctions Order that he was required to sit for a deposition, and he did so. Attached hereto as **Exhibit J** are true and correct excerpts from the deposition of Diego Rodriguez, taken on October 5, 2022.

Where's Ammon Bundy? St. Luke's sued him for 'smear campaign.' Then this happened

Gubernatorial candidate Ammon Bundy and a close associate, Diego Rodriguez, have not cooperated with a defamation lawsuit filed against them by St. Luke's Health System, according to court documents.

Lawyers for St. Luke's have been unable to locate Rodriguez and serve him, while Bundy has been served but has not responded to the lawsuit, according to the documents.

And despite the litigation, both Rodriguez and Bundy have continued to make the kind of accusations the hospital system sued over, and which it asked an Ada County Court to require the two men to cease doing.

In May, St. Luke's [sued](#) alleging that Rodriguez and Bundy orchestrated a coordinated campaign to mislead followers about the circumstances of a child welfare case during an effort to get back custody of Rodriguez's grandson. The state took custody of the young child after authorities said they believed the child's weight-loss could be life-threatening.

The family disputed that, which led Rodriguez and Bundy to embark on a sustained publicity blitz, attacking the hospital — where the baby was briefly held for medical treatment — for "child trafficking" and other alleged crimes. The lawsuit vehemently denied the claims, calling the accusations a "knowingly dishonest and baseless smear campaign" aimed at furthering both of their political careers and earning money.

Bundy, who is running as an independent candidate and is known for far-right armed standoffs with law enforcement, sent out mass messages to his group of activists, called the People's Rights Network. [Multiple protests](#) were held outside of the hospital in Boise. On March 11, the night that local police took custody of Rodriguez's grandson, Bundy was arrested at the St. Luke's Meridian hospital for [misdemeanor trespassing](#).

Protesters went to the homes of government officials involved in the case and published information about those involved online.

On May 12, a process server gave legal papers to Bundy and a campaign staffer in Emmett, where Bundy lives. Since then, neither Bundy nor any lawyer on his behalf has filed responses in court.

Bundy did not respond to a text message request from the Idaho Statesman for comment.

The lawsuit accuses Bundy, his campaign, the People's Rights Network, Rodriguez and associated entities of defamation, invasion of privacy, intentional infliction of emotional distress, trespass, unfair business practices, violating of the Idaho Charitable Solicitation Act and civil conspiracy to commit defamation.

St. Luke's also told the court it quickly needed information about organizations linked to the two men: the People's Rights Network and Freedom Man PAC, a political action committee controlled by Rodriguez.

Ada County District Judge Lynn Norton granted the health system's request on June 3, ordering Bundy to respond to the questions within 14 days, according to court documents.

That did not happen.

On June 24, an attorney for the hospital, Erik Stidham, of the firm Holland & Hart, said in a filing that Bundy had not responded to the court's order "in any way," a document said. The attorney asked the court to sanction Bundy and to require him to sit for a deposition or hold him in contempt.

Bundy has spoken about the lawsuit in the press, stating in an interview that the lawsuit is "an opportunity to further expose them because they are pretty wicked," Stidham's filing said.

An amended summons, filed by the Ada County clerk, said that the court could enter judgment against Bundy and the People's Rights Network if the parties fail to respond to the lawsuit.

The latest filings were first reported by the [Idaho Capital Sun](#).



Ammon Bundy, the far-right candidate for governor of Idaho, has not responded to St. Luke's lawsuit against him. The health system has asked a court to sanction him.

Rodriguez also hasn't responded

A process server attempted to serve Rodriguez with the lawsuit at four addresses in Meridian but could not locate him. The server also conducted "surveillance" at Bundy campaign fundraising event in Meridian in an attempt to locate Rodriguez. He was not there.

In an affidavit, Stidham said that "It appears that Mr. Rodriguez may no longer reside in Idaho."

The attorney also noted that the state has filed a "significant tax lien" against Rodriguez, which the attorney said "creates concern that Mr. Rodriguez has left the state to avoid legal proceedings."

A record of the lien, secured by the Idaho State Tax Commission and filed on Nov. 30, shows it amounted to \$138,393.

Since the lawsuit was filed, Rodriguez has written posts on his website about the activity, saying the health system is suing for his efforts at "exposing" the hospital and its "very wicked hands."

"It's not that he's not aware of (the lawsuit), he's just purposefully trying to avoid engaging with the process," Stidham told the Statesman by phone.

In a text message, Rodriguez told the Statesman that he is living in another country, and he accused the hospital and law firm representing them of corruption and lying.

"I have been out of the country and I am now a resident of another country where I will be for any future hearings," he said. "But I am both happy and willing to participate in all court hearings via Zoom."

Rodriguez did not say what country he has moved to. He previously told the Statesman he was moving to Florida.

He accused the Holland & Hart firm of "untold numbers of corrupt actions against the citizens of Idaho," for actions related to work done for current and prior government officials.

He also said he has not made any false statements about the actions of the hospital or others involved in his grandson's child welfare case, but he believes he will lose in court.

"With the odds stacked against me, it will not matter what evidence is presented at this court trial — I will lose. I accept that," he said.

In an email, Stidham said it is time for Rodriguez to participate in the legal proceedings.

"While dodging the legal process, Mr. Rodriguez continues to manufacture baseless, incoherent conspiracy theories about the hospital, the state government, and law firms," he said. "The time has come for Mr. Rodriguez to stop running away from accountability."

St. Luke's has filed a motion asking for service by publication, which would mean publishing a summons to Rodriguez in a local newspaper.

A hearing on that motion, as well as the request to sanction Bundy, is scheduled to be held on July 12.

Yesterday I received another text message from an Idaho Statesman reporter about news reports regarding the lawsuit from St. Luke's hospital against me and Ammon Bundy. Here is what the text said (actual screenshot):

Hi Diego, I'm working on a story about the St Luke's lawsuit. They hospital says they've made efforts to serve you, but that they haven't been able to locate you. They also said the state has entered a tax lien against you. Would you like to comment on the lawsuit?

Obviously, a newspaper article is only going to pick and choose certain statements to publish (not necessarily nefariously, but there's only so much room available in any given article), so I wanted to give you the entirety of my response here:

First of all, you can bet your bottom dollar that there will be NO REAL JUSTICE in any lawsuit against me or any other liberty minded individual in Ada County. Ada County is bought and paid for by Idaho's "deep state" which is a general cabal made up of Idaho's corrupt politicians, IACI, and other nefarious characters—all of which get their power and money by force—stealing from Idaho's citizens by way of Idaho State Government.

Both recent and past history have demonstrated that there is NO JUSTICE in Ada County. Period. Ammon Bundy was wrongfully prosecuted and found guilty, as well as Casey Baker, Aaron Von Schmidt and untold numbers of innocent Idaho citizens. The details of their court cases demonstrate gross constitutional violations on the part of judges and law enforcement, including at least one police officer who was forced to come back to the courthouse to recant his testimony after evidence was presented that he LIED UNDER OATH, and at least one judge denying Ammon Bundy the right to mention the Constitution in his own case. Well, that is quite a waste of everyone's time because I am happy to publicly recant any single statement I have made and to publish retractions and/or to delete any previous articles or statements about St. Luke's hospital if they can demonstrate ONE SINGLE, SOLITARY FACTUAL INACCURACY that I have stated or published. It is as simple as that—no lawsuit necessary.

Consider this email my attempt to meet and confer.

There is no public right to attend depositions. *See, e.g., Murphy v. United States*, 2017 U.S. Dist. Lexis 205028. You are acting for an improper purpose. You clearly are misleading folks to use them as surrogates to intimidate my clients and disrupt the proceeding. Further, you purposely employed the defamatory language in the email relating to me and my firm in a foolish attempt at intimidation.

We demand that you withdraw the direction to have your supporters log in to the zoom hearing. Further, we plan on having the court reporter create a new Zoom link and also set up the system so that the court reporter must admit each person individually to the email. I reviewed the email and the ex parte communications you sent to the Court. I am not sure what you are asking so I will state my clients' position.

First, we intend to take your deposition on October 5 at the time designated in the Notice. You have the Zoom link. The court reporter and videographer will be located in Boise. In prior correspondence, you indicated that you thought the Order did not apply to you and implied you would not be participating. Your last email seems to indicate that you will participate in the deposition via Zoom on October 5. Please clearly

indicate whether you will be appearing for your deposition via Zoom on October 5. If you are objecting to the deposition, we need to know now so that we can file the appropriate motion with the Court.

First of all, I don't have any zoom link.

Second, my point was that the order was entirely confusing since it stated that "Ammon Bundy" was ordered to sit for the deposition and not me. It later states, *"By September 16, 2022 Plaintiffs must provide Defendant Bundy with three possible dates for the deposition between September 27, 2022 and October 7, 2022."* It then goes on to state *"Defendant Rodriguez is ORDERED to attend the deposition on the date and time provided on the filed Notice of Deposition."*

That is entirely confusing and no reasonable person could be expected to know with certainty WHO it is that is being ordered to do *what*. You obviously know that binding legal documents and orders must be perfectly accurate and/or least clear in order for them to hold validity.

Judge Norton in this case has already demonstrated her keen awareness of this aspect of the law as she previously delayed an order based on the fact that you failed to list the address of the courthouse. ***So she is properly and appropriately abiding by good standards of jurisprudence.*** And I expect her to continue judging and acting appropriately.

Additionally, I responded to the case within the legal timeframe, so it is/was not proper to issue an order when I was fully within the legal time allotted for responding.

Finally, as a third reason why I object to the deposition is the simple fact that I have already fully answered your 5 interrogatories. So it is evident that you have no other goal than to try to bring unnecessary financial stress on me while being able to bill your clients for more money on your end. If you have more discovery questions you'd like to ask, ask them. I'm happy to respond to any question relative to this case.

But these 3 reasons are more than sufficient to demonstrate that this deposition is not meritorious in the context of properly moving the case forward and is solely being used for other purposes.

Second, as soon as possible, we need to know where you will be for your deposition on October 5. As previously indicated, depending on your location, we likely can arrange to have the deposition conducted in person. In general, our preference is to depose you in person. Your refusal to provide your location on October 5 is frustrating especially since we are dubious as to whether you really are out of the country.

As I already told you, I am in Mexico. Specifically, I am in Benito Juarez, though tomorrow, I might have to travel to Mexico City. If that is the case, I will know in the late afternoon.

Third, my clients are not waiving any rights. My clients are not agreeing to forgo seeking attorneys' fees or costs. You have known fully about this lawsuit for months, boasted in the media, and played games regarding service. You have knowingly caused significant amounts of money to be spent unnecessarily in this litigation. Plus, you have continued to defame my clients. I would not be candid if I indicated to you that my clients were willing to forego recovery of costs and fees where and when appropriate.

Erik, you must stop telling lies. It is not good for you, for your client, or for anyone involved in this case. I never "played games regarding service." That is a bald faced lie and you know it. I simply moved out of Idaho and my plans to do so were months in advance of my grandson ever being kidnapped. So you are simply lying. And the fact that I knew about the lawsuit because I openly stated that I downloaded a copy of the initial lawsuit on a news website certainly doesn't qualify as legal service. You know that. So stop lying. You're the one playing games with words and actions. If you cared about the case, you'd simply file things correctly, without error, and you'd obey the letter of the law without trying to rack up additional billing hours for your client.

Fourth, while the October 5 deposition will be limited in scope, we do intend to ask follow-up and clarifying questions regarding the subject matter of the

interrogatories and want to have the responses provided under oath.

That's fine if you have additional questions you want to ask that are relevant to the case. If the judge feels a deposition is in order, then we can conduct one via zoom at *your expense*. Otherwise, I'm happy to answer any additional questions you might have that are relevant to the case, and even file them as affidavits and have them signed by a notary public. Unlike your client, I did nothing wrong. And I haven't made a single statement about your client(s) that is false. Every statement I ever made is either 100% true, or I 100% believed it to be true when I stated it (and still do). 

 21 A. Sure.
 22 Q. What is that associated with?
 23 A. That's just a PO box that I have.
 24 Q. Okay. So how long did Freedom Man
 25 Press and/or the FreedomMan.org website use the

1 State Street, Boise address?
 2 A. I couldn't tell you off the top of my
 3 head.
 4 Q. Can you give me just an estimate of
 5 time?
 6 A. No.
 7 Q. Okay.
 8 A. I can look it up and give you the exact
 9 date if you want to add that to things I need to
 10 get back to you on.
 11 Q. Well, we're going to have some
 12 documents that might help us with timeframe, but
 13 we can follow it up.
 14 A. Okay.
 15 Q. And, again, sir, I'm just asking you
 16 for your estimate or your best understanding. Let
 17 me ask that one more time.
 18 A. Again, off the top of my head, I
 19 wouldn't know what to tell you.
 20 Q. Okay. At any point in time, have you
 21 changed the address for Freedom Man Press or the
 22 FreedomMan.org website from the State Street
 23 address?
 24 A. I don't remember.
 25 Q. Okay. Are you the individual who is

1 responsible for identifying address and contact
 2 information for the FreedomMan.org website?
 3 A. Yes.
 4 Q. You had indicated previously,
 5 Mr. Rodriguez, that FreedomMan.org is your
 6 personal blog and been used in the past to promote
 7 the positions of Freedom Man PAC.
 8 A. Sure.
 9 Q. Which is a political-based action
 10 committee that you were in charge of that no
 11 longer exists; is that correct?
 12 A. That is correct.
 13 Q. Okay. When did Freedom Man PAC cease
 14 to exist?
 15 A. Once I moved out of Idaho.
 16 Q. Did you formally close the political
 17 action committee?
 18 A. Yes.
 19 Q. So would you identify for me any person
 20 who wrote, authored, edited, or otherwise
 21 contributed any information, any support for
 22 content relating to Natasha Erickson that was
 23 posted on the FreedomMan.org website.
 24 A. Anything posted on there was written by
 25 me.

1 Q. Well, let me break that down because I
 2 think there's some additional components to that
 3 question, and I want to ask some a little bit more
 4 specifically. But I appreciate your general
 5 answer. Let me focus on this part, contributed to
 6 content related to Natasha Erickson.
 7 Did anyone, other than yourself,
 8 contribute in any way to the content that was
 9 posted relating to Dr. Erickson on the Freedom Man
 10 website?
 11 A. I don't understand how that question is
 12 different from the question you just asked before.
 13 Everything that's on there about Natasha Erickson,
 14 Dr. Natasha Erickson, I wrote. So 100 percent of
 15 it was written by me, penned by my hand, posted by
 16 me, all of it. So that's the same question you
 17 asked previously. I don't understand the
 18 difference now.
 19 Q. Well, I appreciate you asking for the
 20 clarification. So I'm going to go through kind of
 21 how some of these -- how the question was broken
 22 out in the interrogatory, and we can focus on
 23 those pieces. I think, if I understand you
 24 correctly, I understand your answer except for
 25 "contributed," which we'll get to at the end.
