A Notice of Appeal was filed by Appellant Diego Rodriguez in the District Court on October 4, 2023, from the Judgment entered by District Judge Nancy A. Baskin and filed on August 29, 2023. Thereafter, Plaintiffs' Request for Additional Material in the Clerk's Record was filed in the District Court by counsel for Respondents on October 18, 2023. The due date for filing the Clerk's Record and Transcript was set by this Court on November 20, 2023, and the transcripts requested by the Appellant were lodged in the District Court by the court reporter on January 9, 2024. However, as payment for the additional documents and transcripts listed in Plaintiffs' Request for Additional Material in the Clerk's Record had not been received by the District Court Clerk or court reporters, the Clerk's Record and Transcript have not yet been served on the parties; therefore,

IT IS ORDERED that this appeal shall proceed on only the Clerk's Record and Transcripts requested in Appellant's Notice of Appeal unless the amount due for the additional

documents and additional court reporter's transcripts listed in Plaintiff's Request for Additional Material in Clerk's Record is paid by Respondents to the District Court Clerk and assigned court reporters by Friday, February 16, 2024.

IT IS FURTHER ORDERED in the event the assigned court reporters and District Court Clerk notify this Court of receipt of payment for the transcripts and documents requested, the due dates for preparation of the Clerk's Record and Reporter's Transcripts shall be reset. If payment is not made, the District Court Clerk shall immediately prepare the Clerk's Record which shall include only the documents from Appellant's Notice of Appeal, and serve the Clerk's Record and the transcript lodged on January 9, 2024, on the parties.
