**MOTION TO APPEAR REMOTELY  
FOR HEARING**

COMES NOW, Diego Rodriguez, pro se, and hereby respectfully moves this Court for an order allowing remote appearance via Zoom, telephone, or other approved video conferencing platform for the hearing on the following motions:

1. Motion for Return of Seized Property (filed April 21, 2025).
2. Motion to Expedite Ruling on Motion for Return of Seized Property (filed May 21, 2025).

In support of this motion, I state the following:

1. I reside in the State of Florida and am representing myself pro se in this matter.
2. I have made every effort to comply with Idaho's procedures and have submitted all filings in a timely and professional manner.
3. The cost and logistics of traveling from Florida to Ada County, Idaho, present a significant hardship and would impose an undue burden upon me as a non-represented party.
4. The motions at issue do not require live testimony, and all facts and legal arguments have been fully briefed in my written filings. A remote appearance would allow the Court to address the issues efficiently while protecting my due process rights as a litigant.
5. I am fully prepared to appear via Zoom or any other video-conferencing platform approved by the Court. I am also willing to comply with any technical requirements or time zone adjustments necessary.
6. This motion is made pursuant to **Idaho Rule of Civil Procedure 7(b)**, which governs motions and requests for relief before the Court, and is consistent with the Fourth Judicial District's administrative policies that permit remote appearances upon motion and good cause shown. The undersigned respectfully submits that his status as a pro se litigant residing over 2,000 miles away from the courthouse constitutes good cause for the requested accommodation.

WHEREFORE, I respectfully request that the Court enter an order permitting me to appear remotely for the hearing on the motions listed above.
